**TO: Use Zeeb Road as a Designated Haul Route subject to these additional conditions:**

1. Haul Route Limits: Zeeb Road, between the Gensley Pit located at 2575 S. Zeeb Road and I-94, approximately 2.21 miles.
2. Permit holder is responsible for all hauling operations to and from its source, and shall use the designated haul route.
3. This permit will not be valid for overweight vehicles or loads during Springtime Weight Restrictions or during any other time as determined by the Road Commission.
4. Truck and trailer or semi-trailer shall be limited to an overall combination length of 65', including load.
5. Maximum allowable width is 102", including load.
6. Axle and wheel loadings limited to designated loading maximums as defined on the current WCRC truck operator's map.

**Estimated Tonnage: 1,000,000**

Duration: This permit shall be in effect commencing January 01, 2009 and shall expire in any event on December 31, 2009.
